Overview of Services:

The NHSC builds healthy communities by supporting qualified health care providers dedicated to working in areas of the United States with limited access to care. HRSA requires health care workers to serve in high-need areas. HRSA calls these <u>Health Professional Shortage Areas (HPSAs</u>). NHSC-approved sites provide outpatient, primary health services in HPSAs.

Healthcare entities can <u>apply to become an NHSC site</u>. In some cases, HRSA <u>auto-approves sites</u>. If HRSA approves your site, you gain access to primary care providers.

Who is Eligible for Services:

NHSC offers financial support to primary care providers in NHSC-eligible disciplines and students pursuing a career in primary care, in exchange for commitment to work in a medically underserved area for at least 2 years. They can apply for either <u>loan repayment</u> or the <u>scholarship program</u>.

Overview of Services:

NURSE Corps awards scholarships and loan repayment to nurses, nursing students, and nurse faculty. By supporting these nurses, we build healthier communities across the country—especially in areas of greatest need.

If you apply and are accepted to the NURSE Corps, HRSA will provide you loan repayment or a scholarship in exchange for a minimum commitment of two years of service at a facility experiencing a critical shortage of nurses.

Who is Eligible for Services:

To be eligible for the scholarship, you must be accepted or enrolled in a nursing degree program at an accredited school of nursing located in the United States or U.S. territory:

- Diploma School of Nursing
- Associate Degree School of Nursing (ADN)
- Collegiate School of Nursing (BSN, graduate degree)
- Graduate-Level Nurse Practitioner
- Nursing Bridge Program (RN to BSN, RN to MSN-NP, Direct Entry MSN-NP)

To be eligible for loan repayment, all applicants must:

- Be a U.S. citizen, U.S. national, or lawful permanent resident;
- Have a current, full, permanent, unencumbered, unrestricted license;
- Have earned a diploma, associate, baccalaureate, graduate or doctorate degree in nursing and have outstanding nursing educational loans;
- Be employed as a full-time RN or APRN working at least 32 hours per week at an eligible CSF or an eligible school of nursing.

Overview of Services:

The HSGCF carries out this vision to fund healthcare programs that advance the quality of patient care, patient safety, and community wellness by providing multiple programs to support Missouri Hospital Plan (MHP) member hospitals, including:

The HSGCF's Matching Scholarship Program provides \$4,000 in financial support of students pursuing healthcare related degrees or certificate programs. Since inception in 2013, the program has provided \$1.7M in scholarship funds and has supported over 2,400 students. The scholarship program facilitates the attraction and retention of healthcare professionals in Missouri.

The HSGCF Hospital Team Member Assistance Fund was founded in 2019 to provide a source of support for employees of Missouri Hospital Plan members during times of defined crisis.

The HSGCF developed its first Patient Safety Grant program for hospitals to receive up to \$25,000 in funds in 2022 for projects that improve quality, reduce patient harm and/or improve patient outcomes for Missouri Hospital Plan members. The ultimate goal is to support projects that reduce or eliminate risk of adverse events and improve patient care. Grant recipients agree to share their projects and results and the projects must be adaptable for use by other facilities or physician practices.

Missouri Hospital Plan (MHP) members and Medical Liability Alliance Insureds are eligible for HSGF Scholarship Funds and Team Member Assistance Funds. MHP members are eligible for the Patient Safety Grant.



Overview of Services:

Since 1988, the Missouri Area Health Education Centers (MAHEC) Network (including three AHEC program offices and seven regional AHECs) along with numerous collaborators across the state have taken up the torch to improve the supply and distribution of multiple healthcare disciplines through health career programs for Missouri youth, community-based training, and provider

recruitment. The A. T. Still University (ATSU) AHEC Program Office takes the lead and works collaboratively with the MAHEC Network members to deliver services to support and grow the healthcare workforce across Missouri, particularly in the rural and underserved areas.

The MAHEC Network provides services throughout the state by creating partnerships, amplifying resources, and helping educate communities on the need to proactively recruit, train, place, and retain healthcare personnel in Missouri. Many partnerships with community action groups, social service agencies, and healthcare providers make the MAHEC Network a critical collaborator in improving the healthcare workforce. The MAHEC Network's efforts include:

- Creating academic-community partnerships
- Promoting health careers to Missouri youth
- Promoting high-quality training of health professions students
- Providing educational resources to increase the retention of practitioners
- Identifying and supporting potential health professionals
- Partnering with state agencies and other organizations to promote overall improvement in community health centers

Overview of Services:

The DHSS, ORHPC assumes a leadership role in working and contracting with state and federal agencies, universities, private interest groups, communities, foundations, and local health centers to develop rural health initiatives and maximize the use of existing resources to assist Missouri rural hospitals and clinics be a success. The ORHPC administers the <u>Small Rural Hospital Improvement Program</u> (SHIP), <u>Medicare Rural Hospital Flexibility (Flex) Program</u>, and the <u>State Office of Rural Health</u> (SORH) grants.

The SHIP Grant assists eligible hospitals in meeting the costs of implementing data system requirements established under the Medicare Program, including assisting hospitals in participating in improvements in value and quality to health care such as:

- Value-Based Purchasing Programs
- Accountable Care Organizations
- Payment Bundling

Under the <u>Flex Program Grant</u>, the Medicare Beneficiary Quality Improvement Project focuses on improving the quality of care provided in CAHs by voluntarily reporting measures not required by CMS. The Flex program coordinates technical assistance based on the needs of the Missouri hospitals. The Flex Program supports the CAHs to promote quality and performance improvement including:

- Stabilizing finances;
- Integrating emergency medical services into health care systems;
- Incorporating population health; and
- Fostering innovative models of health care.

Who is Eligible for Services:

SORH – All of Missouri's entities and individuals within rural communities are eligible for services.

SHIP – Missouri's Small Rural Hospitals with 49 available beds or less are eligible to participate in the SHIP. These small rural hospitals provide short-term, general acute care to their communities. They may be for-profit, not-for-profit, or tribal organizations. Critical Access Hospitals (CAH) are considered small rural hospitals and eligible for the SHIP.

Flex Program – CAHs are eligible to participate in the Flex Program. CAHs have a maximum of 25 acute care inpatient beds. For CAHs with swing bed agreements, any of their beds can be used for inpatient acute care or for swing bed services. Any hospital-type bed which is located in, or adjacent to, any location where the hospital bed could be used for inpatient care counts toward the 25-bed limit. Certain beds do not count toward the 25-bed limit, including examination or procedure beds, stretchers, operating room tables, and beds in Medicare certified rehabilitation or psychiatric distinct part units. For a complete list of beds that do not count toward the 25 bed limit, please see Section C-0211, §485.620(a) Standard: Number of Beds: Interpretive Guidelines of the <u>CMS State Operations</u> <u>Manual: Appendix W</u>.

CAHs must be located in rural areas and must meet one of the following criteria:

- Be more than a 35-mile drive from another hospital, or
- Be more than a 15-mile drive from another hospital in an area with mountainous terrain or only secondary roads.

Rural Health Clinics (RHC) increase access to healthcare services for rural Missourians. Missouri's RHCs are an important part in providing health care to our Missouri rural and underserved areas.

Patients receive needed care and benefit from familiarity to physicians, nurses and staff are an important part in patient adherence to their health.

Overview of Services:

The Technical Assistance and Services Center (<u>TASC</u>), a program of The Center, provides information, tools and education to Critical Access Hospitals (CAHs) and to individual state Flex Programs.

The Rural Health Research Gateway provides easy and timely access to research conducted by the Rural Health Research Centers, funded by the <u>Federal Office of Rural Health Policy</u>. Gateway puts new findings and information in the hands of subscribers.

The Flex Monitoring Team (FMT) assesses the role of the Flex Program in facilitating the development of rural systems of care by focusing on the community benefit, assessment, and engagement activities of CAHs and the integration of rural Emergency Medical Services. FMT provides comprehensive information on the finance condition of CAHs, with the goal of improving hospital financial performance. FMT measures the quality performance of CAHs, with the goal of improving access to quality health care in rural communities.

Overview of Services:

The Delta Region Community Health Systems Development (Delta) Project improves healthcare delivery in the Delta Region through intensive, multi-year technical assistance to healthcare facilities in rural communities. The Delta project is a collaboration of the Health Resources and Services Administration (HRSA)'s Federal Office of Rural Health Policy (FORHP) and the Delta Regional Authority.

The project supports capacity building for health care facilities across the following areas:

- Quality improvement: Implementing improvement activities to promote development of an evidence-based culture to improve health outcomes.
- Telehealth: Addressing gaps in clinical service delivery and improving access to care.
- Care coordination: Working collaboratively with the community to increase accessibility to care.
- Population health: Strengthening the local healthcare system to improve population health.
- Integration of social services. Providing services to address broader socioeconomic challenges faced by patients (e.g., housing, child care, energy assistance, access to healthy food, elderly support services, job training).
- Emergency medical services: Ensuring access to, and availability of, emergency medical services.
- Workforce: Identifying workforce recruitment and retention resources targeted to rural communities. Financial and Operational Improvement. Improving financial position and increasing operational efficiencies.

Overview of Services:

The Primary Care Office (PCO) aims to improve access to comprehensive primary care services for underserved and rural populations increasing healthcare workforce to meet the needs of the Missourians. The PCO is responsible for assessing the primary care unmet needs and disparities in Missouri, identifying any barriers to populations or geographic areas, and concerns with the healthcare workforce.

The PCO coordinates the Health Professional Shortage Area (HPSAs) and Medically Underserved Area/Population (MUA/P) designation processes in Missouri to ensure consistent and accurate assessment of underservice including data collection, verification, and analysis. The PCO also provides technical assistance and collaboration to expand access to primary care, including: coordination of the NHSC and NURSE Corps programs, and provider recruitment and retention.

The PCO also coordinates two waiver programs:

- <u>J-1 Visa/State 30 Waiver Program</u>. This program allows a foreign medical graduate to attend an advanced training program in the United States and waives the requirement for graduates to return to their native country in exchange for an obligation to work 3 years in an underserved area of Missouri.
- <u>National Interest Waiver</u>. This program allows foreign-trained doctors to work in underserved areas of Missouri for an obligation of 5 years in exchange for the waiver.

Who is Eligible for Services:

Anyone who needs assistance can contact our office. Those eligible for the waiver programs must be foreign medical graduates who meet the program eligibility requirements.

Overview of Services:

The Health Professional Loan and Loan Repayment programs administered by the Department of Health and Senior Services (DHSS) are designed to increase access to healthcare for Missourians in Health Professional Shortage Areas (HPSAs). In parts of Missouri, a shortage of primary health care providers makes it difficult for low-income, uninsured, and geographically isolated Missourians to receive health care. By working with health care providers and communities, access to care can be improved for the underserved.

There are 4 Health Professional Loan and Loan Repayment programs administered through DHSS:

- <u>Nurse Student Loan Program</u> awards funding for eligible educational expenses to qualified students pursuing careers as licensed Practical Nurses or Professional Nurses in Missouri.
- <u>Nurse Loan Repayment Program</u> awards funding for the repayment of eligible educational loans for qualified Registered and Advanced Practice Nurses in Missouri.
- <u>Student Loan Repayment Program</u> awards funding for the repayment of eligible educational loans for qualified Health Professionals, Physicians, Dentists, and Psychiatrists in Missouri.
- <u>The Primary Care Resource Initiative for Missouri</u> awards funding for eligible educational expenses to qualified students pursuing careers as licensed primary care Physicians, Dentists, Dental Hygienists, and Psychiatrists in Missouri.

Who is Eligible for Services:

Healthcare professionals and students who meet the requirements of the loan and loan repayment programs.
